- b. Statewide Updates
 - i. Kansas Water Plan: Sara explained a draft of the Water Plan was posted for public comments in the fall and KWO is currently working through these comments to create a finalized document.
 - ii. Kansas Water Authority Update: Sara summarized the Kansas Water Authority (KWA) meeting held on April 20, 2022.

address the chloride plume issue. Discussion of the red cedar tree issue was held, including thoughts on lowering the fire premiums in the region and concerns about the fires and water shortages the trees are connected to.

d. Agency Updates

i. Ron Graber of KDHE opened a discussion regarding the WRAPS program, including talk of educational activities, former contracts, and no till practices. Additionally, Ron mentioned the newsletter that highlights producers that practice conservation. A field day at Flickner Innovation Farms was discussed as well.

Regional Activities

- a. Review Goals I and II: The committee opened discussion regarding their first two sets of goals and action plans.
 - i. Goal I: Promote sustainable balance of groundwater withdrawals with annual recharge in the Equus Beds Aquifer. Ensure safe yield and recharge rate calculations in the Equus Beds Aquifer are accurate through a district wide, integrated groundwater and surface water model.
 - 1. Tim Boese updated the group on the ground and surface water model, explaining that the model is complete and updated at this point.
 - **ii. Goal II:** Encourage the development and use of comprehensive water supply plans by major water users in the region. Plans should account for long-term supply and demand, vulnerabilities within a water supply system, and potential for improved water efficiency.
 - 1. The group decided to revisit this goal at their next meeting. KDHE will be looking into public water supply information for this region.

Other Business

- **b. Questions and Future Issues from RAC Members:** The committee inquired about the upcoming Governor's Water Conference and the annual WRAPS meeting.
- c. Meetings
