- a. Statewide Updates
 - i. Kansas Water Plan: Sara Crawley of KWO announced the completion of the Kansas Water Plan.

ii. Kansas Water Authority Update: Sara summarized the Kansas Water Authority (KWA) meeting held on October 19, 2022.

b. Regional Updates

i. Open Discussion from Members: Brian Meier opened discussion about funding for items such as drought maintenance, dredging, and dams. Follow-up questions included inquiries about categorization of funding, as well as the extent of certain projects needing funding.

Discussion continued with talk of GMD2 well plans, scheduled to be completed spring of 2023, and questions regarding how those wells are monitored.

c. Agency Updates

- i. David Bollenback of KCC echoed updates mentioned earlier in the meeting, discussing wells scheduled to be drilled East of Burton.
- **ii.** Allison Herring of KDHE discussed budget, covering topics such as nondiscrimination, lead lines, and water quality.
- **iii.** Ron Graber of KDHE discussed producers' concerns for blue/green algae and Allison added information about the EPA filling several positions.
- iv. Don Henry explained the phases of drought response for the city to the group, although no action is being taken at this time.

Regional Activities

- a. Review Goals III and IV: The committee opened discussion regarding their first two sets of goals and action plans.
 - i. Goal III: Implement watershed protection measures to improve the reliability and health of surface water resources in the region.
 - 1. Ron wondered if we are making measurable water quality improvements. The group agreed that, although tough to quantify, our resources have grown, thanks to the City of Wichita.
 - **ii. Goal IV:** Allocate necessary resources to accurately locate, characterize, prioritize and remediate contamination sites within the Equus-Beds Aquifer.
 - 1. Tim Boese mentioned that this goal is something he is currently working on and that most of the chloride problem areas have been identified at this point.
