4. Kansas Water Authority Update: Matt Unruh provided an update on the December and January Water Authority meetings and corresponding legislative visits. The Governor's Budget recommendations were presented by highlighting items of interest to the region. New administration will be working on an annual budget. Chairman Steve Hieger, expressed the need to find additional ways to engage the legislature and discuss water issues at a deeper level.

5. Regional Activities

- a. Wichita ASR Permit Modification Proposal Update: Matt Unruh provided handouts from the latest public hearing that took place on December 11, 2018, and alerted committee members of upcoming public hearings. The March 26th hearing has been postponed. A new date for the formal phase of the hearing will be announce in the near future. Tim Boese of GMD 2 shared an update on their four expert reports and offered to provide those to anyone interested. Joe Pajor directed the committee to the city's website https://wichitaasr.org/ for additional information including videos, expert testimony and reports. - b. RAC Action Plan Implementation Update: Matt Unruh asked the RAC what the Water Office could do to provide more frequent updates on goal status. The RAC was also asked if there were opportunities to elevate water issues through educational activities. Mr. Hieger expressed his concerns, shared by other RAC chairmen, on how keep the RACs relevant and maintain momentum. The chairman asked the committee and audience to provide ideas on how they adapt to various levels of funding and how that impacts the execution of a 50-Year Vision for the Future of Water in Kansas. The group discussed the need to share examples of success in the region as tools for awareness and education. Mr. Hieger suggested incorporating these concepts into actionable items.
- c. **Equus Beds Water Technology Farm Update:** Matt Unruh briefly discussed planning efforts for potential establishment of new Tech Farms in the Equus-Walnut region. - d. **2019 RAC Membership Drive:** Committee members with 2019 term expirations were notified and will be up for reappointment. During the month of May, KWO will have an open call for applications to all RACs. All applications will be reviewed in June, and action will be made at the July Water Authority meeting in Goodland, Kansas. Newly appointed members will have a 4 year term that runs through June 30, 2023.

Matt Unruh discussed upcoming training in RAC operations this fall. The effort is meant to more clearly define roles and responsibilities of RAC members. Mr. Black requested there be information on advocacy in the training. Matt Unruh asked for additional ideas on training topics.
