Kansas Water Office Updates

- a. Statewide Updates
 - i. Kansas Water Plan: Sara Maguire explained a draft of the Water Plan was posted for public comments in the fall and KWO is currently working through these comments to create a finalized document.
 - **ii.** Kansas Water Authority Update: Sara summarized the Kansas Water Authority (KWA) meeting held on January 27, 2022.

b. Regional Updates

- i. **RAC Membership:** Sara announced that Byron Warta has left the RAC and that KWO is accepting applications to replace him in the Conservation/Environment category.
- ii. Brian Meier opened the floor for open discussion from members but no comments were made.

- c. Agency Updates
 - i. Tim Boese with GMD2 said his office his fully staffed and is reviewing safe yield calculations. All parties involved in the Wichita Recharge Project have until February 11, 2022 for comments. The wells in the Burton area are projected to be replaced this year.
 - **ii.** Don Henry discussed budget priorities and the new water treatment plant in Wichita. Water levels in the Cheney reservoir are currently low.
 - iii. Ron Graber with WRAPS discussed the BMP program and how 313 acres are being added to the existing 500 acres allocated to this program. The 5-year contract is nearing the end and 100 acres will be expiring. The next 3-year grant beings July 1, 2022.
 - iv. Jeff Lanterman with KDA said the annual crop well measurements have been collected.
 - v. Jeff Klock with KCC answered questions from the group regarding funding and contracts.

Regional Activities

- a. Arbuckle Study: Josh Olson with KWO gave an update on the Arbuckle Study. The Arbuckle Study Group last met in December 2021 and since then, a new subcontractor has been brought on board to collect measurements. The Kansas Water Authority has recommended an additional \$150,000 in funding for the project in FY 2023 and Governor Laura Kelly included this number in her recommendations as well.
- **b. Produced Water Pilot Update:** Sara and Josh explained there are currently setbacks on the manufacturer's side of the Produced Water Pilot due to creation and budgetary problems.
- c. Review Goals and Action Plans: Sara discussed the region's current goals and action plans. The group decided to work through these little by little over the coming months.
