Kansas Water Office Updates

- a. Statewide Updates
 - i. **Kansas Water Plan:** Sara explained a draft of the Water Plan was posted for public comments in the fall and KWO is currently working through these comments to create a finalized document.
 - ii. **Kansas Water Authority Update:** Sara summarized the Kansas Water Authority (KWA) meeting held on April 20, 2022.
 - The group voiced concerns regarding their previously proposed message regarding Bill 2686 to KWA and the lack of attention given to this conversation in the most recent RAC meeting notes. Many were disappointed that the proposed message to KWA was not passed on. KWO representatives explained that the RAC Operations Committee did review the message and decided against sending it through to KWA as the bill had already been dissolved at that point in time. Committee members agreed to reword their message to encompass all similar bills in the future.
 - 2. The group voted in favor of amended the meeting notes from February 2022.

c. Agency Updates

i. Orrin Feril gave an update on GMD5, discussing data collection at Rattlesnake Creek, moving forward with Walnut Creek Intensive Groundwater Use Control Areas (IGUCA), the wheat harvest, and progress with the Conservation Reserve Enhancement Program (CREP).

Regional Activities

- a. Review Goals I and II: The committee opened discussion regarding their first two sets of goals and action plans.
 - **i. Goal I:** Achieve water use sustainability within the Great Bend Prairie Regional Planning Area that includes a reasonable raising or lowering of the water table based on average weather conditions.
 - 1. The group discussed buzzwords such as "sustainability" and "reasonable." Orrin confirmed the modeling references are still accurate.
 - ii. Goal II: Developed for Municipalities and Rural Water Districts. Maintain annual training funds of 15% from Clean Water Drinking Fee and increase technical training support to Public Water Supply (PWS) systems to enhance new technology and increase water efficiently and effectively, thus reducing water loss. Utilize available municipal/residential/commercial "LAWN" irrigation training programs provided by the Irrigation Association.
 - 1. Berry and Craig opened a discussion about the City of Winfield and data collection.

- b. Questions and Future Issues from RAC Members: None.
- c. Meetings
- i. Great Bend Prairie RAC: The next RAC meeting will be scheduled around early August.
- ii. **KWA:** The next KWA meeting is scheduled for June 22nd in Pittsburg.
