V. Regional Activities

a. **Budget Discussion & Recommendations:** A presentation was given by Matt Unruh (KWO) over the State Water Plan Fund that included budget information specific to the region. The presentation was followed by discussion from RAC members on areas of interest that they wish to pass on as budget recommendations to the KWA budget committee for consideration. A motion was made by Berry Bortz and seconded by Stephanie Royer to send the following Budget Recommendation Message to the KWA Budget Committee:

"The Great Bend Prairie RAC requests the Kanas Water Authority to seek to provide funding to programs and projects benefiting the region consistent with the revenue derived from the Great Bend Region. The following programs would be the first priority to receive additional funding for the region.

- a) Support for WTAP and CREP with increased funding
- b) Support for local Conservation Districts and ensuring that they receive their full funding allocations
- c) Water quality testing to address issues with chloride and nitrate concentrations
- d) Support GMD5 Groundwater Model update
- e) Continued support for research on alternative crops."

There was no discussion and unanimous approval was given.

VI. Other Business

- a. Agency Reports:
 - i. Steve Frost, KDA-DOC reported on changes and updates to CREP that have occurred that pertain to the region.
 - ii. Cameron Conant, KDA-DWR reported that they had been busy with the usual actives and had nothing new to report on at this time.
 - iii. Orrin Feril, GMD5 reported on updates to the watershed planning project submittal, water banking, and CIG program.
 - iv. Jaide Allenbrand, KDHE had nothing to report at this time but would be available for any questions.

- c. **Future Agenda Items from RAC Members:** It was requested to have the next meeting in late October, with a presentation on CREP updates from Steve Frost. It was agreed to have Keadron Pearson (KWO) send out a doodle poll in the coming weeks to set up a meeting date.
