- Discussion of Kansas Water Plan Partnership Initiative (KWPPI) Grant: Chris led this with a PowerPoint located <a href="https://example.com/here">here</a>. She mentioned all the partners that have been contacted and are willing to participate in the grant: NRCS, Glacial Hills RCD, Archer Daniels Midland, WRAPS, Doniphan County CD, and ADM-Farmer to Farmer. There are three goals of the proposed project: Improve water quality, Reduce vulnerability and Increase awareness of Kansas water resources. Chris mentioned that this project would address the Missouri RAC Goal #3 and listed 5 items that would be used to improve water quality. The Proposed project would also address Missouri RAC Goal #4 and listed 3 items that would increase awareness of Kansas water resources. Finally, the proposed project would address Missouri RAC Goal #5 by slowing water and reducing excessive flooding,

reducing the vulnerability to Extreme events. Michelle asked about budget for the project and Chris said they have matching funds for over \$700,000 from the partners with a total ask of \$1.4 million. She also mentioned this project could be downsized or extended into multiple years depending on the funding that is made available through the KWPPI grant. A portion of this funding could be used in areas of the county that traditionally has missed out on funding however, the NRCS ranking would still be applied. Carl moved that a letter of support should be drafted by Tj for the project. Joel amended the motion so that Michelle would sign the letter of support. Jeff seconded the amended motion and it was approved unanimously.

- **Other Issues/Events or Agency Updates:** Chris mentioned the Conservation District Annual meetings and that this is a good opportunity for KWO to interact with producers. The County meeting list is not available yet, but should be finalized soon.
