- **IV. Review of May 2022 RAC Meeting Notes:** The meeting notes from the May 2022 meeting were reviewed. There were no additions or corrections. The meeting notes were accepted as submitted.
- V. Discussion of State Water Plan Fund Webinar: The Kansas Water Office Planning and Outreach Coordinator for the Neosho Region, Angela Anderson, reviewed the material presented during the State Water Plan Fund Webinar. She indicated that the RAC was welcome to use the provided link to share individually their recommendations for budget line item support. The Neosho RAC discussed that sense they were all together, they would prefer to supply a recommendation from the RAC as a whole and that their priorities were the same as the year prior.

It was mentioned that with the shortage of cost-share funds to the conservation districts for water resources and non-point source pollution, that a lot of the local environmental protection program (LEPP) sanitary systems projects are not getting support and funding.

The Neosho RAC supplied the following budget priorities:

1. Sediment/Nutrient Reduction

- *Sediment Management & Reduction Technologies (KWO)
- * Streambank Stabilization (KDA)
- * Non-Point Source Pollution (KDA)
- *BMP Implementation (KWO)
- * WRAPS Program (KDHE)
- * Riparian and Wetland (KDA)

Aquatic Nuisance Species Program (KDWP) – To be included for consideration as a State Water Plan Fund budget recipient rather than fee assessment through KDWP

Flood Mitigation (KWO)

- * FIRO
- * Basin storage evaluation

Education

- * Water Vision Education (KWO)
- * Demonstration Farms (KWO)
- 2. The Neosho RAC supports a 20% increase in the priority items listed.
- 3. The Neosho RAC supports the addition of funding for the Kansas Department of Health & Environment's LEPP program.
- 4. The Neosho RAC supports enhanced funding package in addition to KDHE's LEPP and the Nutrient Trading Pilot Program in the Neosho Basin and funding the administration of the program in the amount of \$150,000.
