- I. Welcome and Introductions: Chairman, Don Hellwig (Agriculture), called the meeting to order at 10:32 am. Don called on each attendee for a brief introduction before beginning the meeting.

(Agriculture (cc)) to submit the RAC budget feedback to the KWA Budget Committee. The RAC's budget input was approved to send onto the KWA Budget Committee.

"The Solomon-Republican Regional Advisory Committee (RAC) would like to pass the following feedback to the Kansas Water Authority Budget Committee for consideration for the FY 2025 State Water Plan Fund.

- 1. The RAC would like to highlight the following progress of note for the regional and statewide water resource issues:
 - Reporting and progress from the Kansas Bostwick Irrigation District on their updates and efficiencies
 - Bathymetric surveys done by the KWO
 - Streambank stabilization projects completed throughout the state
 - Increased push on farmer to farmer meetings through the conservation districts
 - Increased education and awareness for soil health practices
- 2. The RAC would like to highlight the following activities that could potentially be most impactful under the Guiding Principles.
 - Continued efforts for streambank projects and ditch erosion
 - Agency manpower more technical assistance needed throughout state
 - i. Encouraging younger folks to take on contracting jobs/agency positions
 - ii. Promote the recruitment of workforce through agency scholarship & internship programs
 - Drought mitigation
 - Increase education & cost share programs for non-point source pollution
 - *i.* Developing educational/informational materials specific to towns/areas targeting municipalities (under the 10,000 pop. Threshold)
 - *ii.* Addressing increased nutrient & pesticide application with the reduction of tillage practices
 - iii. Funding opportunities for newer technologies that could help in reducing nutrient & pesticide application
- 3. The RAC would like to recognize the following activities as the highest priority under the 5 Guiding Principles:
 - Water resources cost-share program
 - Non-point source program
 - *Aid to conservation districts*
 - General water education
 - i. Through in-school curriculum
 - ii. Working with local units of government
- 4. The RAC would like to highlight the following as "low hanging" issues or priorities that should be addressed:
 - Conservation district programs
 - i. Non-point source program funding
 - ii. Water resources programs
 - WRAPS funding
- 5. The RAC would like to address the following urgent emerging issues, priorities, and unique opportunities:
 - Including road ditch erosion within streambank stabilization projects framework
 - Rural water districts not having enough water
 - Addressing HAB issues
 - Reduce economic damage and water supply vulnerability due to drought

- **a. KWA/KWO Updates:** Victoria Potts (KWO) informed the RAC that the House Water Committee will be holding an interim meeting in the coming months.
- b. Regional Event Sharing: No regional events were shared at this time.
- IV. Agency or Public Comments: Katie Basiotis (KDHE) shared with the RAC that the Non-Point Source plan update has been started and is due next year. Dan Wells (KDHE) added that the Environmental Conference will be held August 9th and 10th. He also stated that within FY23, KDHE has taken around 320 HAB samples. Finally, Dan mentioned that the Washington County pipeline spill has been completely cleaned up by TC Energy. Chelsea Erickson (KDA-DWR) shared that the Republican River Compact Annual Meeting is to take place August 31st in Burlington, Colorado. She said that there is virtual as well as in-person attendance options. She also updated the RAC about streamflow conditions within the region, stating that the Smoky Hill Access District might run for the first time this year.
