They also talked about information that would be helpful to have presented to the committee at future meetings. It was mentioned about reaching out to the local community colleges on ways to help educate young adults on water conservation. Other items requested were to have a presentation on programs that help promote soil health to improve water quality and receiving more information on Randy Stotler's new findings in research for recharge through natural process. It was agreed that the Planner, Keadron Pearson, would work closely with the chair to set up future agenda items for meetings.
