5. <u>Regional Activities</u>

a. Budget Discussion & Recommendations: A presentation was given by Matt Unruh (KWO) over the State Water Plan Fund that included budget information specific to the region. The presentation was followed by discussion from RAC members on areas of interest that they wish to pass on as budget recommendations to the KWA budget committee for consideration. No action was taken by the RAC due to a quorum of members not being present due to a member having to leave the meeting early, however those in attendance wanted to send the following budget recommendations to the KWA Budget Committee for consideration. It was the consensus of the committee members present to send the following Budget Recommendations to the KWA:

"The Upper Republican RAC supports the proposed budget and wishes to place emphasis on the following items that are important to fund in order to accomplish and carryout the goals and actions plan of the Upper Republican RAC. These items of interest include increased support for programs that provide education and outreach to the public, regional efforts that help promote water conservation and water quality, Water Technology Farms (KWO), Water Conservation Areas (KDA), Certified Irrigator Program (GMD 4), and Kansas Runs on Water (KWO)."

<u>Chelsea Erickson (KDA-DWR Stockton Field Office)</u>: reported on the upcoming Interstate Water Annual Republican River Compact Meeting in August and they she would be sharing about the projects going on in Cheyenne County.
