- **a. Approval of RAC Goals & Actions Plans Update Recommendations:** Members reviewed revisions made to the RAC Goals & Actions Plan made during the previous meeting. A motion was made by Farrin Watt to accept the updated Goals & Actions Plan as presented to be sent to the KWA for approval. The motion was seconded by Alicia Allen. There was no discussion. The motion passed.
- b. Budget Discussion and Recommendations: A presentation was given by Cara Hendricks, KWO Assistant Director, over the State Water Plan Fund that included budget information specific to the region. The presentation was followed by discussion from RAC members on areas of interest that they wish to pass on as budget recommendations to the KWA for consideration. A motion was made by Alicia Allen and seconded by Bo Parkinson to send the following Budget Recommendation Message to the KWA:

The Upper Smoky Hill RAC supports the proposed budget and would like to highlight the following priorities that are important to fund in order to accomplish and carryout the goals and actions plan of the Upper Smoky Hill RAC. These items include Local Enhanced Management Areas (LEMA) (KDA), Water Conservations Areas (KDA), Subbasin Water Resources Management Programs (KDA), Water Technology Farms (KWO), support for Regional Conservation Partnership Programs (NRCS), Water Transition Assistance Program (KDA), support the development of a Certified Irrigator Program (GMD 4), increased support for programs that provide research, education, and outreach to the public, and Kansas Runs on Water (KWO).

There was no discussion and unanimous approval was given.

**c. Membership Status and Participation:** The Chair informed members of three vacancies on the committee for "At Large Public (cc)", "Agriculture Industry", and "Financial" and that there were currently two pending applications to fill two of those categories.
