1. Welcome and Introductions: The meeting was called to order at 1:02pm by Chairperson, John Ditmore (Industry/Commerce). John took roll call.

2. Approval of Agenda:

reservoir operations and mitigate **the effects of** drought.", instead of "The Kansas Water Office will continue to find ways to optimize reservoir operations and mitigate drought."

The meeting notes were accepted as corrected Angela will make the necessary notifications within the Kansas Water Office to get that wording adjusted.

- **4. Governor's Conference Review:** Angela showed the group where they could find the Governor's Conference presentations on the KWO website to view at their leisure.
- 5. Kansas Water Plan Update/Input on draft Water Quality Section & Education Resource Sections
 Angela informed the group that the Kansas Water Plan is currently going through its regular 5-year update. The
 Water Plan is one of the primary tools used by the State to address current water resource issues and to plan for
 future needs. The Kansas Water Plan guides the coordination of local, state, and federal actions. The two draft
 Guiding Principles documents provided in the meeting materials were provided due to the expressed interest in
 the RAC's Goals/Action Plans in regards to Water Quality and Education. There are other Guiding Principles
 that will be shared with the RAC.

Angela stated that the Kansas Water Office is accepting feedback/comments on the draft Water Plan. Anyone may send those comments to the email on the website, kwo-info@kwo.ks.gov, or to Angela.

Ron Smith (Industry/Commerce) inquired concerning the lack of nitrates measured in southeast Kansas as depicted in the "Nitrate Test Results in Public Water Supply Systems, December 2010 to March 2019" map provided by KDHE. Angela Anderson will contact some individuals to find an answer. Richard Rockel indicated on KDHE's website, some nitrate monitoring results are posted on the Drinking Water Watch tab.

6. Public Water Supply Vacancy – John informed the group that with Chuck Shively's retirement, the Public Water Supply (cc) is open. It was noted that a representative from Fredonia Public Wholesale 23 might serve the committee well. A couple of names were provided to the group. Ron Smith and others will make some connections. Angela informed the group that the person interested would need to fill out an application to join the Committee. The application would then be brought forth to the Kansas Water Authority after going through a KWA subcommittee. Names may be brought to Angela and she will supply an application.

(The GoTo Meeting shutdown the meeting four times, resulting in loss of attendees. No action was taken from this point.)

7. Questions and Future Issues from RAC Members:

Bob Culbertson (Conservation/Environment) asked if the southern portion of the basin is still facing drought conditions. John answered that the river levels appear good and that the intermittent, small amounts of precipitation have helped. Gary Koons (KWO), currently serves as KWO lead representative on monitoring drought, highlighted the Drought Webinar the KWO hosted which indicated drought conditions are forecasted to persist at least until Spring 2021.

8. Agency Input:

Gary Koons informed the group that through his drought monitoring, he has been keeping an eye on the Verdigris Basin and Southeast Kansas, both specifically. He will continue to keep the group informed. Angela Anderson thanked John Ditmore for his great leadership with his first meeting wrought with technical difficulties.
